Financial Plan Summary: Susan Staudt presented. See attached report. Balance on Hand in Bank as of 9/30/19 is \$239,973.29.

Elder Team Report: Craig Baker presented. Elders are updating their call lists and mini-flock lists and will continue to contact all on their lists.

Education Team: Felicia Salgado presented. The first Children's Christmas Program practice is Nov 6 and presentation will be during 10:45am Worship in the ARC; Nov 14 is the Preschool Thanksgiving Feast.

Outreach Team: Pedro Santaliz presented. Trunk or Treat will be Oct 30 and volunteers will be needed; more ideas for Outreach will be discussed after Christmas; Charlotte Bradley presented the KTT Afterschool Report and thanked St. Paul's for hosting and making this ministry possible to continue.

DCE Report: Felicia Salgado presented. A Marriage Retreat led by Jimmy & Carol Mueller upcoming in 2020; Mothers of Preschoolers) MOPS meeting 2nd & 4th Fridays @ 9:30 here at St. Paul's is doing well and Rhonda Reece is a mentor for this group; 98.5FM Radio has asked Felicia to do an interview and there may be an opportunity for a women's devotion in the future.

Trustee Report: Rich Maschke reviewed completed projects. Replacement of Sanctuary roof project to be completed soon; Oak Leaf Hollies purchased this summer and stored by Lanny Yocom will be planted this fall; a generous donation provided funds for the removal of the shrubs.

Finance Team Report: Carol Morgan presented attached report; Legacy Endowment Fund was discussed.

- The Sanctuary Roofing project was delayed due to delay in delivery of materials; plan to start Monday Oct 28; the east end parking lot and near the Sanctuary entrance will be marked off and access limited.

Anyone else interested in serving to establish the goals and procedures for the Fund's management. Any ideas may also be presented to Jeff.

- Emphasizing the priority of meeting the income goals of the 2020 Financial Plan, Don Olson presented a motion that the Payoff of the Sanctuary Roof proposal approved by the August 18, 2019 Voters Assembly be extended to be completed in two years; it was seconded; the ayes passed the motion.

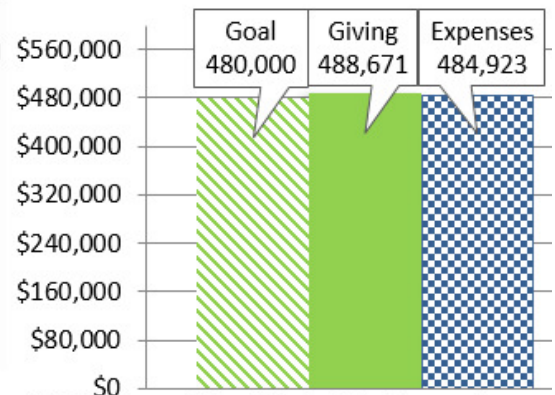

Our Giving through Dec of \$488,671 exceeded our Goal by \$8,671 - to God be the glory!

Our Financial Plan for 2019 projected \$480,000 for both our FirstFruits Giving and our ministry Projected Expenses for an average of \$40,000/mo. Actual \$40,723 for Giving and \$40,407 for Expenses. **Our Expenses of \$484,879 are less than our Giving by \$3,792 as we implemented our Plan with full ministry staff.**
